- Reducing our carbon footprint as part of a carbon management strategy.
 Improvements successfully delivered between 2020 -2022 include:
 - Switched our electricity supplier to a provider of 100% Green Electricity
 - We replaced all our old CFL lights in our offices with new LEDs. According to the SEAI this has the potential to reduce lighting energy consumption in the region of 45 -90%.
 - Replaced all the single glazing windows with double glazing throughout the offices reducing heat loss by up to 35%.
 - Retrofitted the office attics with insulation reducing heat loss by up to 30%
 - Replaced old storage heaters with new temperature controlled Dimplex heaters improving room heating energy efficiency by 8-10%.

Opportunities identified for completion 2022 - 2025

- Replace all old T8 Light fittings in Warehouse with new LED Lights and occupancy sensors with potential to reduce lighting energy in these areas in the region of 45-90% in accordance with SEAI Energy Guidelines.
- Optimise energy efficiency and conservation in all operations.
- Controlling and managing energy efficiency in our business and promoting energy efficiency.

- Reducing the impact of transportation of our goods.
 - We have changed the way we distribute our goods from our warehouse in Dublin to our customers nationwide providing carbon neutral shipping via UPS.
- UPS carbon neutral is just one way we are reducing our transport impact on the environment.
- We are constantly evaluating our goods in supply chain, ordering in bulk and holding stock on behalf of customers for shipment by sea to eliminate carbon intensive transport by air.
- We will replace all our diesel company vehicles with Electric Vehicles by 2030.
- We will install EV charge points at our office in 2023 and are expecting the delivery of our first vehicle by April 2023.

Waste

- We use Thorntons Recycling as our waste recycling provider.
 - Thorntons Recycling implements rigorous environmental policies and ensures that both Thorntons Recycling and its clients meet their obligations under both EU and Irish regulations.

- Supporting a sustainable circular economy by Actively promoting the reuse and recycling both internally and amongst our suppliers and customers.
 - We segregate all our Cardboard
 - We will engage with Thorntons to introduce a food waste/ composting bin and learn how to reduce our general waste streams and increase the recycling of Plastic packaging.
- Minimising waste generation by applying reuse and recycle options where possible.
 - We will engage our packaging suppliers to confirm the recyclability of existing cardboard boxes.
 - We will engage our suppliers of labels and packaging tape, bubble wrap to confirm materials and identify further improvements.
- Reducing packaging on all our products where feasible through better design.
- We will Improve our sustainability / recycling communications with our customers to clearly outline where / how to recycle our transport packaging and delivered goods.

Continuous Improvement

Our goal is to achieve ISO 14000: 2015 Environmental Management System Accreditation by 2023 to identify, manage and control our activities that have an environmental impact.

ISO 14000: 2015 will complement our existing ISO 9001: 2015 Quality Management Standards already in place enhancing our commitment to quality and environmental performance opposite our customers.

Benefits of achieving ISO 14000: 2015 for Hall-Pyke helps:

- Strengthen stakeholder confidence ISO 14001 reduces risk of liability, keeps ahead of legislation and regulatory developments and reduces the environmental burden through elimination, reduction and options
- Greater competitive advantage –achieve improved cost control, improved organisational effectiveness and image of organisation
- More secure long term viability this environmental management standard facilitates effective management, demonstrates environmental focus and introduces change in a controlled manner
